Fund Balance Allocation ---

The Board of Education approved the allocation of \$480,000 from the 2013-2014 Unassigned General Fund Balance for the purpose of reducing the 2014-2015 tax levy.

Transfer to Capital Expenditure ---

The Board of Education modified the 2013-2014 budget to record the Transfer to Capital expenditure, general fund expense account A9950.9000-12 of \$1,600,000 funded from the unassigned fund balance to the voter approved Capital Reserve II (2010) fund.

Reserve Funds ---

The Board of Education authorized the continuance and establishment of various general fund reserve accounts for the 2014-2015 school year at amounts not to exceed the following:

BOND REFUNDING ---

The Board of Education approved a resolution authorizing the issuance, pursuant to Section 90.10 of the Local Finance Law, of refunding bonds of the Cold Spring Harbor Central School District and providing for other matters in relation thereto and the payment of bonds to be refunded.

Contract for Financial Statements ---

The Board of Education entered into an agreement with Don Angelo and Associates, CPA's, PC, of Melville, New York at a fee of \$4,200 to prepare the financial statements of the Cold Spring Harbor Central School District as of and for the year ended June 30, 2014 pursuant to the Government Accounting Standard Board Pronouncement No. 34.

Weed Control Application ---

New York State Education Department requires Board of Education approval on emergency applications of weed control in areas that are classified as playing fields, the application will be scheduled to not interfere or conflict with any student scheduled activities. The Board of Education approved a onetime application of weed control herbicide on and adjacent to the running track at the Jr./Sr. High School and that the application will be made by a licensed pesticide applicator and all regulations concerning neighbor notification will be followed.

Fertilizer Application ----

New York State Education Department requires Board of Education approval on applications of fertilizers in areas that are classified as playing fields and the application will be scheduled to not interfere or conflict with any student scheduled activities; the Board of Education approved a onetime application of fertilizers on the playing fields district wide - as needed. This application will be made by a licensed pesticide applicator and all regulations concerning neighbor notification will be followed.

BOCES Contract for Services ---

The Board of Education approved the Services Contract with Western Suffolk BOCES in the amount of \$1,224,624 for the 2014-2015 school year under the provisions of sections 1950-51 of the Education Law.
