

## **Board of Education “Meeting Highlights” November 18, 2014**

### **President’s Report...**

BOE President Anthony Paolano’s report included the following:

*There has been a lot happening throughout the district since our last meeting. All of the buildings celebrated Halloween with various activities, including a Halloween parade at Goosehill Primary. At Homecoming, our football team beat Oyster Bay. Lloyd Harbor School celebrated the 23<sup>rd</sup> Little Apple Fun Run. And West Side is a work in progress on their 225<sup>th</sup> Anniversary festivities.*

*This year, our Athletic Director, Mr. Bongino, will hold a Varsity Awards Ceremony at the PAC on November 24 at 7pm for the Fall Sports. We can be very proud of some of the accomplishments that our Cold Spring Harbor teams had!*

*The Board of Education on Veterans Day made our annual inspection tour of West Side, Lloyd Harbor, Jr/Sr. High School and earlier this evening, Goosehill. This is the time that the building principals can make recommendations directly to the BOE as it pertains to their individual needs and improvements. It allows the BOE to get an understanding and be able to prioritize the various potential projects to be considered in our budgeting of our Capital Reserve Funds. Thank you to all the building principals and our director of buildings and grounds, Mark Margolies, for all of your preparation, input and explanations. The BOE will be meeting shortly to discuss the potential projects with our Superintendent of Business, Bill Bernhard, Mark Margolies and our architect, John Grillo.*

## **Superintendent's Report...**

Dr. Judith A. Wilansky's report included the following:

You may have read a troubling story in today's *Newsday* entitled, *College? Yes, but No* which explores data published from the National Student Clearinghouse, an organization that ostensibly tracks whether students who intend to matriculate in college, actually do so. In Cold Spring Harbor's case, the report indicated that for the class of 2012, the school reported to the State Education Department that 96.5% of the class had reported that they would be matriculating at either a 2 or 4 year college, but the National Student Clearinghouse data indicated that only 79.2% of the students were enrolled within one year of graduating high school.

One might read the article and conclude one of the following:

- A) *the district had misreported the number*
- B) *that students did not attend when the fall rolled around*
- C) *the student did not succeed in their first year at college*

None of these conclusions would reflect well on the Cold Spring Harbor schools.... which is why we took the time today to examine the data listed on the National Student Clearinghouse.

This is what we discovered.

Under the Family Education Right to Privacy Act, students may block their data from being included in the National Student Clearinghouse Directory. If one reads the fine-print in matriculation paperwork - and many of our families do - they may choose to exercise this right.

In 2012, we had 167 graduates and the Clearinghouse reports data for 132 students. We generated a list of the remaining students, and based on our most current knowledge (i.e. *today!*) we can assert that 27 of the 35 unaccounted students attended college that fall – and are still in attendance as of today. So much for the National Student Clearinghouse. Data is valuable only when it is accurate. Sorry, community *Newsday* readers, for the false alarm.

On another note, tonight, we officially conclude the 2013-2014 school year with the presentation of the Annual Report, which provides an overview of the school year with regard to student performance, district goals and noteworthy events in the schools, athletics and district departments. Also, Mrs. Bellino will be sharing the annual report card. Once again, we examine quantitative data with an eye of what can be learned and, of course, how to continually improve student performance.
