# "Board of Education "Meeting Highlights" June 14, 2016

## **President's Report...**

BOE President Robert C. Hughes' report included the following:

As I looked over the agenda for tonight's meeting, I was struck by how wonderful it is to end the school year by recognizing the accomplishments of so many members of our educational community.

As we do every year, we have recognized a group of outstanding juniors with the annual book awards. These students have demonstrated excellence in academic achievement and will undoubtedly continue to be successful in college and beyond. We recognized the success of our student athletes. As we have just heard, for the second year in a row, the Boys Lacrosse team has won the Class C State Championship. We also recognized a member of the staff who has demonstrated exemplary service over many years. #### 1. State and Municipal Facilities Capital Program:

The Cold Spring Harbor Board of Education authorized the expenditure of funds from its voter approved Capital Reserve Fund III and/or from the General Fund pursuant to the State and Municipal Facilities Program Grant award of \$119,900 for funding the "ADA Compliance and School Safety Improvements.

## 2. Establishment of Reserve Funds:

The Board of Education authorized the continuance and establishment of various general fund reserve accounts for the 2016-2017 school year at amounts not to exceed the following:

#### 3. Fund Balance Allocation

The Board of Education approved the allocation of \$200,000 from the 2015-2016 Unassigned General Fund Balance for the purpose of reducing the 2016-2017 tax levy.

## 4. Budget Modification from Capital Reserve

The Board of Education modified the 2015-2016 budget to record the Transfer to Capital expenditure, general fund expense account A9950.9000-12, of \$1,000,000 funded from the unassigned fund balance to the voter approved Capital Reserve II (2010) fund.

## 5. Joint Municipal Cooperative Bidding Resolution

The District authorized and appointed Western Suffolk BOCES to represent it and to act as the lead agent in all matters related to the services for various educational and municipal corporations located within the State of New York desire to bid jointly for Tutorial & Special Education Services for Students, Western Suffolk BOCES & Component School Districts - RFP #16-17-03PIE5-LH-, Opened March 17, 2016, Term of Contract: July 1, 2016 through June 30, 2017.

## 6. Audit Response Plan

The Board of Education approved the School District Audit Response Plan dated June 14, 2016 for the Internal Audit Report on Capital Projects for the period from July 1, 2015 to February 1, 2016 as prepared by R. S. Abrams & Co. LLP.

## 7. Tuition Costs - Cold Spring Harbor Lab Students

The Board of Education approved the tuition costs for the Cold Spring Harbor Lab students to be based on 65% of the calculated New York State Seneca Falls non-resident tuition formula beginning with the 2015-2016 school year.

## 8. Transportation Contract

The Board of Education approved an extension of the Transportation Contracts with Huntington Coach Corporation for the 2016-2017 school year.

## 9. Fund Raising Proposal

The Board of Education approved the fundraising proposal from the Lloyd Harbor PTG for the purpose of installing an 85' x 60' Sport Court that will replace the current blacktop along the back of the Lloyd Harbor school to the left of library. The proposed cost of the purchase and installation of the Sport Court is \$86,000

#### 10. Service Contract - Western Suffolk BOCES

The Board of Education approved the Services Contract with Western Suffolk BOCES in the amount of \$1,635,066 the 2016-2017 school year.

#### 11. Contract - 403(b) Plan Administrator

The Board of Education approved an agreement with The OMNI Group for the 2016-2017 school year to provide services as a third party administrator of the Cold Spring Harbor 403(b) Plan.

#### 12. Contract - Internal Auditor

The Board of Education, appointed R. S. Abrams & Co. to perform an annual risk assessment update of the District's operation and that the internal audit perform testing and validation for one Internal Control system during the 2016-2017, prepare written reports, and assist the district in implementing recommendations based on the findings.
