## Board of Education "Meeting Highlights" May 10, 2016

## President's Report...

BOE President Robert C. Hughes' report included the following:

Three weeks ago, the Board reviewed progress on several of the goals we set back in October. Potentially the most far reaching of these goals is "to further integrate the use of technology into teaching and learning by exploring the feasibility of piloting 'one to one' computing for Jr. High School students." To be completely unfair, one could define 1:1 learning as giving each student a tablet device. But a meaningful 1:1 experience is much more than just technology. It requires utilizing that technology to its fullest extent so that it becomes a tool of effective teaching and learning and not just an expensive substitute for a notebook and pencil. We need to ensure that the widespread use of technology is guided by innovative approaches to teaching, such as the approach to small group instruction we saw demonstrated by some of our elementary school teachers at the April meeting.

Work on the 1:1 initiative continues. In anticipation of a successful completion of that work, the Board has allocated money in the budget, so we will be ready to implement an effective program when that work is done.

Speaking of the budget, next Tuesday is a very important day in the school calendar. Residents will be given the opportunity to vote on the budget for the next school year. As you will hear in a few minutes during the Budget Meeting, the budget features a tax increase of less than 1% and is below the district's tax cap limit. We encourage all residents to come to the Field House next Tuesday (May 17) between 6:00 a.m. and 10:00 p.m. to cast their votes.

#### **Appointments**:

Danielle Gil - was appointed leave replacement working in the Social Studies Department at a per-diem rate effective May 6, 2016 through June 24, 2016.

Kristen Wilkens – Secondary LOTE Teacher HS, this is a four-year probationary appointment in the tenure area of LOTE effective August 31, 2016, subject to applicable laws and regulations regarding the granting of tenure.

#### **Personnel Contracts:**

The Health Care Contracts between the District and Susanleigh Perissi, Felice Kestenbaum, and Jane Tofel, Teacher Retirees, were approved as submitted.

Official Consultants, Ltd: The Contract for Services between the District and Official Consultants, Ltd., at a per diem rate of \$750 for the period May 31, 2016 through June 9, 2016 was approved as submitted

### **Health Services Contracts:**

The Board of Education approved the contracts with Westbury UFSD for health services for 1 student attending private schools in the 2015/16 school year, and with the Mineola Union Free School District for two students attending private schools in the 2015/16 school year.

### **Additional Business Matters:**

- 1. The Board of Education approved the charter and by-laws for the Baking Club to begin operating during the 2015-2016 school year.
- The Board of Education approved a contract extension for the 2016- 2017 school year, with Triad Group, LLC, Troy, New York for Workers Compensation Claims Administration Services at an annual fee of \$9,600 and that the President of the Board of Education be authorized to execute such contract.
- 3. The Board of Education approved the Claims Auditor's reports for warrants, with exceptions and notes as reported, for reports dated April 1, April 8, and April 15, 2016.
- 4. The Board of Education accepted the Audit Report related to internal controls for Capital Projects of the Cold Spring Harbor Central School District for the period from July, 2015 through February 1, 2016 as performed by R. S. Abrams & Co. LLP.
- 5. The Board of Education delegated to the President of the Board of Education of the Cold Spring Harbor School District the power to authorize the issuance and sale of Tax Anticipation Notes of said school District in anticipation of the collection of real estate taxes levied or to be levied for the fiscal year of said school district commencing July 1, 2016.
- 6. The Board of Education entered into a professional service agreement with KGO Consulting, Inc. for the purpose of providing the Board of Education assistance with the administration of the State Environmental Quality Review Act for a proposed building addition at the Jr./Sr. High School (Fitness Center) at a fee of \$850 and that the President of the Board of Education be authorized to execute such agreement.
