# Board of Education "Meeting Highlights" April 18, 2017

# **President's Report...**

BOE President Amelia Brogan's report included the following:

It is hard to believe that we are in the fourth and final marking period of the 2016-2017 school year. The induction ceremony for the World Language National Honor Society has taken place and we look forward to the induction ceremonies for the Sr. High National Honor Society on April 26th and the Jr. High National Honor Society on April 25th. We are very proud of all of our students who have earned these distinctions. I also want to take a moment to acknowledge and congratulate our National Merit Finalists: Alec Israeli, Katherine Northacker, Ezra Brody, and Benjamin Basil. As National Merit Finalists, this designation places these students in a group representing about half of the top 1% of American high school seniors. This designation is based on rankings of the students' scores on the PSAT which is given in the Fall of the students' junior year. This is quite an accomplishment and we are proud of these students.

I hope everyone was able to see the Jr. High School musical production, "Bye Bye Birdie". It was a wonderful show. It always amazes me the talent we have here in our schools. Thank you to everyone who was involved in making this production such a big success.

Tonight, we are very excited to appoint Mr. Joseph Monastero to Executive Director of Instructional & Administrative Technology. After years as Assistant Principal at the High School and years teaching social studies, we look forward to Mr. Monastero's guidance, innovation and enthusiasm as he embarks on this new role. As we continue with the roll out of our 1:1 chrome book initiative and infusing technology into all aspects of academics, it became apparent that this new role in instructional and administrative technology is critical in moving us forward into 21st century learning. As a district wide position, I know everyone in all of our school buildings is looking forward to working with Mr. Monastero.

After extensive screening and interviewing, we will be appointing our Director of Humanities, Ms. Theresa Donohue, and our Director of STEM (Science, Technology, Engineering and Math), Ms. Meridyth Hansen. We are excited to welcome these professionals into our Cold Spring Harbor family. These directors will add value to our curriculum and offer support to our faculty. We look forward to continuing to enhance existing programs as well as building upon our foundation of excellence to offer our students outstanding opportunities and a solid base for college and career readiness. We also will be appointing Ms. Lori Messina as a School Counselor. She brings experience in the college admissions process and we welcome her to our guidance department.

We are also pleased to announce we will be appointing our next Assistant Superintendent of Business at a special Board of Education meeting to be held next week on April 25th at 8:30am

in District Office. We invite everyone to come to meet and welcome Mr. James Stucchio into our community.

We want to thank Mr. Fenter and our administrators for the letter they sent to the community regarding the importance of the state assessments in ELA and Math and the valuable information these tests provide us which enables us to better inform instruction. Although we were hoping for a lower test refusal rate, Cold Spring Harbor experienced a 19% opt out rate for the ELAs which was below the rate of test refusals at other school districts on Long Island. Math assessments are scheduled for the first week in May and we again encourage our students to sit for these tests.

Tonight, we will be approving a contract for construction management services which will enable us to proceed with this summer's nearly \$2.8-million-dollar capital plan projects. As you may remember, over the last few years, most of our capital projects approved by voters in prior years were delayed in SED, thereby preventing us from moving ahead with them as originally planned. Although most other school districts routinely hire construction managers to oversee their capital projects, Cold Spring Harbor has been extremely fortunate to have Mr. Mark Margolies who has handled our projects for us, and we truly appreciate the time and effort Mr. Margolies and his team has put into accomplishing this for us. No small task! However, the sheer volume of projects we wish to complete this summer, makes it impossible for Mr. Margolies to oversee them as well as perform his own duties. Therefore, after careful deliberation and presentations by Mr. Margolies and Mr. Grillo, our school architect, as well as consideration as to the importance of these projects and associated costs that could be incurred if we further delay construction, we decided it fiscally prudent to proceed with these projects this summer with a construction manager overseeing them. Capital projects will be taking place on all of our school campuses. We want to thank Mr. Margolies and his team for all the hard work and their commitment to the CSH school district. They continuously perform beyond expectations and we are truly thankful to them for all they do.

Tonight, the Board of Education will be formally adopting the Proposed Budget for the 2017-2018 school year and the Proposed 2017-2018 Property Tax Report Card. The proposed Budget remains within the allowable tax cap and maintains all programs in all of our schools as well as includes new class offerings, initiatives and enhancements which will benefit all our students here at Cold Spring Harbor schools. Thank you to Dr. Bernhard and all of our administrators for drafting fiscally responsible and academically centered budgets. We know a lot of time and thought goes into this process which truly benefits all of our students.

Looking forward, the Central Parents' Council will be hosting a "Meet the Candidates' Night" for the Board of Education on May 8th at district office at 8pm. This is an opportunity for residents to ask questions of the candidates. We are holding our Budget meeting on May 9, 2017, here in district office at 8pm. This meeting is open to the public and all are welcome. Please mark your calendars for the annual budget vote and Board elections which will take place on May 16th at the Field House from 6am to 10pm. I strongly encourage everyone to get out and vote.

# Superintendent's Report...

This effort, to spend quality time with our leaders, teachers, support staff, and students, is an important step in my learning about the culture of our schools as well as the teaching and learning that takes place every day in our classrooms. I was also reminded that our teachers and leaders work so hard to create learning environments that are positive and provide our students with confidence as they engage in exciting, challenging and meaningful work. Tomorrow morning, I will be spending the day at the Jr./Sr. High School in classes that are making use of our Chromebooks. My thanks to our building principals for organizing these residency days and my thanks to all of our staff members who welcome me into their classes each time I visit.

- 1. Adoption of Proposed 2017-2018 Budget and Proposed 2017-2018 Property Tax Report Card: The Board of Education approved the adoption of the 2017-2018 Cold Spring Harbor District Budget in the amount of \$66,623,073 and the Board approved the 2017-2018 Property Tax Report Card.
- 2. Internal Audit Report: The Board of Education acknowledged receipt of the Internal Audit Report on the *System to Track and Account for Children* of the Cold Spring Harbor Central School District for the period from July 1, 2016 to February 28, 2017 as performed by R. S. Abrams & Co. LLP.
- 3.
