President's Report...

BOE President Amelia Brogan's report included the following:

It is always amazing what our students and staff achieve. Again, congratulations to the boys' varsity lacrosse team who became the 1st L.I. boys program to ever win three consecutive state titles. Also, it was a privilege to honor and present Liz Lynch with the Exemplary Service Award recognizing her outstanding service to this district. We are very lucky to have her. We also are looking forward to acknowledging fifteen students who have the highest grade point averages in their class at the end of their junior year. Shortly, each of these students will be presented with a Book Award. We look forward to these recognitions. This past Sunday was the High School graduation. It was a beautiful day and very HOT! As usual, Mr. Matuk and our faculty and staff did a wonderful job. The students' "Reflections" and musical programs were fabulous. This graduation was especially notable, as it was Mr. Matuk's last and Mr. Fenter's first. Importantly, we would also like to thank this community for supporting our school budget. Thus, the English and math tests would each be given over two days rather than three. We'll have to see what impact this will have on the number of students who opt-out. And as I promised to report on the 8th grade trip to Wash., D.C., it was wonderful. It was packed full of sightseeing, museums and historical sites. Thank you to Mr. Monastero and his team for a memorable time! Finally, as this is our last regularly scheduled Board meeting of the 2016-17 school year, we wish everyone a warm, sunny and healthy summer with family and friends. Of course, we invite you to attend our work session this Friday to hear about our five-year outlook presented by Dr. Bernhard, and to our meetings in July and August.

Budget Adjustment:

The Board of Education approved the allocation of \$550,000 from the 2016-2017 Unassigned General Fund Balance for the purpose of reducing the 2017-2018 tax levy.

The Board of Education modified the 2016-2017 budget to record the Transfer to Capital expenditure, general fund expense account A9950.9000-12, of \$1,300,000 funded from the unassigned fund balance to the voter approved Capital Reserve III (2015) fund.
