Board of Education "Meeting Highlights" May 9, 2017

President's Report...

BOE President Amelia Brogan's report included the following:

What a lovely reception honoring those members of the Cold Spring Harbor Central School District family who are retiring this year, and for those who are receiving tenure tonight. Although remarks have been made about each retiree here tonight, we would like to add that your service to our students will not be forgotten and we thank you for the impact you have had on our school community. We wish each and every one of you all the best in your future endeavors.

Also, this evening's reception honored three individuals who will be receiving tenure in their respective area of practice. The granting of tenure is something we take extremely seriously and is granted only to those who are of the highest caliber. With that in mind, we are proud to be granting Mr. Santoli tenure in the area of Teacher Assistant, Ms. Sihksnel tenure in the area of L.O.T.E, and Ms. Wolf tenure in the area of Special Education. We will also be appointing Ms. Jordan District-Wide LOTE/FLES Chairperson. We are very proud of you and we look forward to continuing a partnership of excellence with you.

This past week, the NYS Math assessments were administered to our students in grades 3-8. Similar to the ELA assessments, Cold Spring Harbor schools experienced a 19% opt-out rate. However, for those students in Algebra who will be taking the Algebra regents in June, they received a waiver and did not have to sit for them. However, because our participation in the ELA and Math assessments fell below the 95% participation threshold, no school in the Cold Spring Harbor Central School District is eligible to be designated as a "Rewards" school. Although schools in our district have earned this distinction in the past, we are again ineligible due to our opt-outs. The announcement naming which schools earned the "Rewards" designation will be made by the State on or about May 25th.

But on a happier note, recently, the US News & World Report published its annual list of "Best High Schools" in the United States. We are very proud that once again, the Cold Spring Harbor Jr/Sr High School ranked in the top 1% of high schools nationally. Keep up the good work!

One week from today is the budget vote which will be held at the CSHHS Field House on May 16th from 6am to 10pm. We encourage everyone to take the time and to make the effort to vote. Please remind your spouses, neighbors and friends to vote as well. The Board of Education is proud of the school budget we have proposed and hope the community turns out in support of it. In reaching our goal of proposing a well-balanced, educationally sound and fiscally responsible budget, the Board of Education listened to input from our community, diligently explored and examined the budget line by line and met with all the administrators and building leaders. This was done to ensure that the best possible budget would be proposed which would take into account what is in the best interests of our students as well as our fiscal responsibility to all the tax payers in the Cold Spring Harbor school district. With these high standards in place, the Board of Education was able to achieve its goal of proposing a sound and prudent budget that remains within the allowable state tax cap. Thank you Dr. Bernhard and everyone involved in this process.

I would also like to thank the Central Parents Council for hosting the Meet the Candidates Night on May 1st. This is the annual meeting where the community has a chance to meet and ask questions of the candidates running for the Cold Spring Harbor school board. So thank you, CPC.

Two weeks ago, Lloyd Harbor PTG held its Little Apple Fun Run which was well attended and where fun was had by all. In two weeks, on May 21st, the West Side PTG will hold their West Side School Run. If you haven't participated in either of these events, I strongly encourage you to give it a try. These are really fun times, and there is no judgement should you prefer to walk instead of run.

It is also that time of year, when our high school juniors are getting ready for their prom on May 19th. This is a memorable evening shared by our juniors, their parents, faculty and building leaders. A lot goes into the planning and execution of this special night and we thank Mr. Matuk, the faculty advisors and everyone involved.

Lastly, the annual 8th grade trip to Washington, D.C. will be taking place the week of May 22nd. I am particularly looking forward to it as I have volunteered to go as a chaperone. Ms. Squicciarini is also chaperoning so we will be able to give a comprehensive report when we get back.
