Dear Sixth Grade Parents and Students:

As you know, on **November 8, 2017**, sixth graders will have the opportunity to attend a matinee performance of **Charlie and the Chocolate Factory** on Broadway (*Lunt-Fontanne Theater*). There will also be a morning workshop prior to the show for which students will be prepared by their teachers. On this day, children will be working with members of the cast and other professionals in the field. We are thrilled to be able to present this unique opportunity to our students.

**The buses will leave Lloyd Harbor promptly at 8:00 am.** We cannot wait for children who are late. Students should eat a good breakfast before coming to school. The workshop will take place from 10:30-12:00. **Students must pack a lunch**, which they will have time to eat between the workshop and the 1:00 pm performance. A snack will be provided on the bus coming back. It is not necessary for the children to bring any money with them for shopping or food, as our time in the theater is limited.

**We hope to return to school at approximately 6:00 pm.** If the time deviates more than a half hour (either way), a "connect ed" message (automated call) will be sent to your primary phone number. Parents should pick up their children by the Little Theater entrance. Please park your car and walk to the door to meet your child.

**Students should remember this is a Broadway performance and dress accordingly.** Sports jerseys, athletic attire and shorts are not appropriate for this trip. Additionally, the children have been reminded that school rules are in effect and electronic devices, **including cell phones, may not be used during the trip (as well as on the bus).** *If your child is seen using any electronic device, it will be taken away by an adult and returned to the parent after the trip.*
